Privacy statement

This is the privacy statement of The Board for plantvarieties. It explains how we handle your personal data. We respect your privacy. This statement clarifies which personal data we collect and the purposes it is used for. We ensure any personal data that you disclose to us is always handled confidentially.

1. Personal data that we process

The Board for plantvarieties processes your personal data as you use our (statutory) services and/or because you have provided us with your personal data.

The personal data we process is shown below:

2. Why do we process your personal data?

We process the data above for one or more of the following purposes (partly depending on which service or functionality you use) to:

- process your payment
- contact you by telephone or e-mail if this is necessary to perform our services
- inform you about changes to our services and products
- answer your questions or handle your complaints via social media, e-mail, by post or by telephone
- allow you to create an account in the myNaktuinbouw portal

3. Automated individual decision-making

We do not make decisions based on automated processing if they concern matters that can have (significant) consequences for natural persons. These are decisions taken by computer programs or systems, without the intervention of a natural person (e.g. a Board employee).

4. Data retention

We do not store personal data longer than is necessary for the purpose of data processing or that required under the Dutch Public Records Act.



5. Sharing personal data with third parties

The Board for plantvarieties does not sell your data to third parties and only discloses it to third parties if this is necessary for the performance of our agreement with you or to comply with a legal obligation. For example, the Netherlands Food and Consumer Product Safety Authority(NVWA) may request your data from us in the context of research or a report. We conclude a processor agreement with companies that process your data on our instructions to ensure the same level of security and confidentiality of your data. The Board for plantvarieties remains responsible for this processing.

6. Right to access, change or delete data

You have the right to access, correct or delete your personal data. In addition, you have the right to withdraw your consent to data processing and to object to the processing of your personal data by the Board and you have the right to data portability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organisation specified by you.

You can submit a request for access, correction, deletion, data transfer of your personal data or submit a request withdrawing your consent or objecting to the processing of your personal data by e-mail.

To ensure that the request for access to this data has been submitted by you, we kindly ask you to send a copy of your identity document with the request. To protect your privacy, black out your passport photo, MRZ (machine-readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) in this copy. We will respond as quickly as possible, but no later than within four weeks, to your request.

The Board would like to inform you of your right to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.

7. How we protect personal data

The Board for plantvarieties takes the protection of your personal data seriously and takes appropriate measures to prevent misuse, loss, unauthorised access, unwanted disclosure and unauthorised modification. If you are under the impression that your personal data is not properly protected or there are indications of data abuse, please contact us via e-mail.

myNaktuinbouw

For variety registration and Plant Breeders' Rights testing, we will solely show the results of tests. No rights can be derived: the authority to grant Plant Breeders' Rights rests with the Board for Plant Varieties.

Login myNaktuinbouw

A user of myNaktuinbouw is obliged (on request of Naktuinbouw) to provide Naktuinbouw with all essential information regarding the login. The user guarantees that all the information submitted is complete and correct and must ensure that any amendments made to this information are communicated immediately to Naktuinbouw. The user is responsible for ensuring that his/her login will only be used for personal use. The login data provided is intended solely for personal use by the user and may not be disclosed to third parties without the express, written permission of the provider. The user is obliged to solely use the login for the purpose for which it was provided to the user. We cannot be held liable for the login data managed by the user.

Cookies

The Board only uses technical and functional cookies. A cookie is a simple, small file that is sent when you visit the website for the first time and stored by your browser on the hard disk of your computer, your tablet or smartphone.
